About The Institute of Chartered Accountants of India

The Institute of Chartered Accountants of India (ICAI) is the apex body in the field of accountancy and auditing. ICAI, a partner in nation building, is also involved in on-going accounting reforms and improvement of financial reporting and public financial management in various Government entities/ departments including Local Bodies in India.

About The Committee on Public & Government Financial Management

The Committee on Public and Government Financial Management (CP&GFM) was constituted 2019 to carry forward the initiatives of erstwhile Committees i.e., Committee on Public Finance & Government Accounting and Committee on Accounting Standards for Local Bodies in a synergised manner in the direction of improving Public Finance and Government accounting including in the Local Bodies in the Country.

The Institute of Chartered Accountants of India (ICAI) through its Committee on Public & Government Financial Management (CP&GFM) plays a major role in improving financial reporting and empowering public financial management system in Government in India. ICAI is engaged in constant dialogue with Ministry of Housing and Urban Affairs, Ministry of Panchayati Raj, Office of Controller General of Accounts and office of Comptroller and Auditor General of India apart from several State Governments to give organisational support to accounting reforms in Public Financial Management System in India.

Terms of Reference

- 1. To conceive of and suggest areas in which ASLBs need to be developed and formulate them.
- 2. To examine how far International Public Sector Accounting Standards (IPSASs) prepared by the IPSAS Board (IPSASB) of the International Federation of Accountants (IFAC) can be integrated into national Accounting Standards for Local Bodies envisaged in paragraph (i) above and to integrate the same to the extent possible with a view to facilitate global harmonisation.
- 3. To review, at regular intervals, the ASLBs from the point of view of acceptance or changed conditions, and, if necessary, revise the same.
- 4. To provide, from time to time, interpretations and guidance on ASLBs.
- 5. To enable creation of a supportive environment for implementation of ASLBs and respond to issues arising therefrom.
- 6. To formulate comments on the drafts of accounting standards for governmental bodies issued by various authorities including IPSASB of the IFAC.
- 7. To provide support to Government(s) and regulators, e.g., the proposed Governmental Level Technical Committee to be constituted under the aegis of Ministry of Housing & Urban Affairs (MoHUA) and C&AG, in their endeavours towards various other aspects of financial reporting including preparation of asset registers, performance measurement, budgeting, costing, internal control and audit.
- 8. To review, analyze, assist, recommend and suggest measures to the Central, State & Local Government in the areas of Policy assessment, planning and execution in public finance.
- 9. To collaborate and coordinate with relevant authorities and various Ministries/ Government Departments/Local Bodies for developing a mechanism of improving the Government Accounting System and enhancing the role of members of the Institute of Chartered Accountants of India thereat.
- 10. To provide awareness of Public Finance, Government Accounting & ASLBs to the society at large and specifically to the stakeholders including inter–alia to employees of the government, C&AG, members of the profession, media, NGOs and to citizens generally including appropriately addressing the training issues.

- 11. Enhancing the accountability and transparency in public service delivery mechanism.
- 12. To bring out newsletters, publications, and other useful inputs in areas of contemporary issues related to public finance and accounting standards for Local Bodies.
- 13. To suggest checks and balances for monitoring periodical review/ audit of end use of funds.
 - 1. To increase the role of ICAI and its members in the various "Financial Inclusion" initiatives of the Government which would mainly emphasis on:
 - 2. Assisting government in bringing appropriate regulatory and educational policy framework in place.
- 14. Collaborating intensively with different chambers and associations of industry.
- 15. To carry out such other work relating to Public Finance, ASLBs and other related aspects as may be entrusted to it by the Council.

Activities undertaken by the Committee during February, 2019 - February, 2022

This 3 year Activity Report gives a glimpse of activities undertaken in last 3 years and highlights the progress of the Committee. During COVID- 19 pandemic, the Committee introduced several novel steps and did not allow learning to suffer amongst members. Online batches of the Certificate Course on Public Finance and Government Accounting and Live webinars on variety of topics were organised to avoid large gatherings and to let members gainfully utilise the time of lockdown, thereby turning this threat (lockdown) into an opportunity (of enhancing knowledge) and gaining new skills. Several Central Government Ministers, Ms. Sadhvi Niranjan Jyoti, Hon'ble Minister of State for Rural Development, Government of India (Gol), Shri Bhupesh Baghel, Hon'ble Chief Minister of Chhattisgarh, Dr. Sanjeeb Patjoshi, IPS, Joint Secretary, Ministry of Panchayati Raj, Gol, Shri Nagendra Nath Sinha, Secretary, DoRD and several IAS officers are some of the luminaries who have already interacted with our members and other stakeholders on this platform. 7. Status Paper on Accounting Reforms in Urban Local Bodies in India (2019-20)

The Status Paper on Accounting Reforms in Local Bodies in India issued during 2009 has been updated in order to incorporate the developments & progress held in the direction of adoption of accounting reforms over the decade.

Accounting Standards for Local Bodies (ASLBs) issued

The Institute of Chartered Accountants of India (ICAI) has been formulating Accounting Standards for Local Bodies (ASLBs) since March, 2005 to improve financial reporting of Government at the third-tier of Government, i.e., Local Bodies that are moving towards accrual accounting. The objective of these ASLBs is to make various divergently used methods and principles, uniform, comparable, consistent and to bring transparency in financial statements of local bodies that are the critical building blocks of our Government sector. These ASLBs are based upon the globally accepted accounting standards in Government sector and also take into account the India's unique governance and demographic features.

In the Council Year 2021-22, the Committee has been able to complete the whole bouquet of ASLBs relevant for India comprising of 30 ASLBs (including one cash based ASLB to facilitate transition to accrual system of accounting). With the approval of the Council, the following three ASLBs corresponding to the respective IPSASs which have been submitted for consideration by the Technical Committee on Budget and Accounting Standards for PRIs/ULBs for recommending the same to States for adoption by the respective local bodies:

- 1. ASLB 35, 'Consolidated Financial Statements;
- 2. ASLB 37, 'Joint Arrangements';
- 3. ASLB 38, 'Disclosure of Interests in Other Entities'.

Empowering Local Bodies - Way ahead for Chartered Accountants

Finance Commissions, one after another have laid emphasis on creating an ecosystem for proper maintenance of accounts and their audit by local bodies. Consequent to the recommendations of Fifteenth Finance Commission availability of annual accounts for the previous year and audited accounts for the year preceding previous year in the public domain online is an entry level condition for qualifying for any grant for Local Bodies. Chartered Accountants can support them in key aspects of their functioning and enabling them to become eligible for the grants in the times to come. Read on...

Finance Commission, a constitutional body, prescribes recommendations for allocation of funds amongst Central and State Government (s) including Local-Self Government. Local-Self Government (also known as local bodies) plays a major role in providing infrastructural facilities and basic services to the citizens, e.g., supply of water & electricity, education, health, transport, etc., and also take care of planning, development and administration of villages, towns or cities.

The final report of Fifteenth

Finance Commission (XV FC, chaired by Mr. N. K. Singh) along with recommendations for the five year period (2021-26) was placed in the Parliament in February 2020. XV FC has prescribed various recommendations to enhance the resource cover, promote timely availability of accounts online and further empower Local Self Government (both Urban Local Bodies (ULBs) and Rural Local Bodies (RLBs)). Successive FCs have recommended enhanced grants to LBs, as detailed below:

2. Moving in Unison with the Government in Public Financial Management (May 2021 issue)

Moving in Unison with the Government in Public Financial Management

The three-tier governance system in India comprises of Central, State and Local-Self Government. The public expenditure done by the Government in India is huge. Therefore, various initiatives have been and are being taken in India to strengthen and encourage timely financial reporting, public financial management and auditing system in Government so as to ensure greater accountability and enhanced transparency. For any part of the government using tax-payers' money, availability of accounts (including audited accounts) in the public domain on a timely basis is a primary requirement for good governance. Read on ...

Availability of accounts in public domain is important as a part of good governance for government. The lack of timely accounts, including audited accounts, on a timely basis has been identified as one of the major problems with the accounts of local governments in India. XV Finance Commission (report for the year 2020-21) recommended forming an expert group to draft legislation to provide for a statutory framework for sound public financial management system consistent with international best practices. It observed requirement of an overarching legal fiscal framework to provide for budgeting, accounting, and audit standards to be followed

at all levels of Government. It also recommended for the integration of the Panchayati Raj Institutions Accounting Software (PRIASoft) and National Municipal Accounts Manual (NMAM) systems with the State-level Integrated Financial Management Information System (IFMIS) and subsequently with Public Financial Management System (PFMS) to achieve complete integration of accounts of all the three levels of Governments for better control and targeted utilisation of resources for the desired purposes.

Consolidating the same, in its report for 2021-26, XV FC amongst others, mandated the availability of annual



Projects in Progress- Study Project with NITI Aayog

ICAI/ICAI ARF with NITI Aayog have initiated a study on "Transition to accrual accounting in urban local bodies: implementation models and lessons learned from select Indian States". Chhattisgarh, Delhi, Gujarat, Karnataka, Maharashtra, Nagaland, Odisha, Rajasthanand Tamil Nadu have been selected for the Study. States were selected on the basis of maturity levels of their reforms as well as their geographical distribution. A comprehensive questionnaire covering various aspects of the reform implementation. Interviewer teams were guided by the study objectives, inputs received on the basis of the questionnaire and deliberations held in interviews with various ULBs have also been captured in the publication. The study has been submitted to NITI Aayog for its consideration.


